Doorbell remained unanswered. CTA compliance manager heard dogs barking inside the CCFFH. After 10 minutes, CG#1 was seen arriving in a white compact car and parked at the CCFFH's driveway. Per CG#1- a HHM (age 17yo) was left with the 3 clients while she went out on an errand. When CTA compliance manager and CG#1 entered the CCFFH, there was no HHM present in the CCFFH. Per CG#1, HHM just left in a taxi. No taxi was heard nor seen around the CCFFH area.

All 3 clients in the CCFFH required 1-2 persons assistance to transfer out of bed and would not be able to independently evacuate from the CCFFH in the event of an emergency/fire.
