

Met ewe Ofesen Fosun Fonu (Office of Language Access – OLA)?

Ewe **Office of Language Access (OLA)**, **wewen ewe Ofesen Fosun Fonu**, a kan achocho ne anisi ekkewe chon LEP non Hawai'i pwe repwe tongeni angei aninis seni chommong sokkun ofesen muun, usun prokramen social services, prokramen kaeo, prokramen aninis angang, pwan prokramen aninis faniten mwichen kapung.

Ewe Testen Aruanun Napanap (Four Factor Analysis)

Ewe Four Factor Analysis ew **tettenin foforen attitina** mei chok nonom faniten ekkewe agency/ofesen muun pwe repwe tongeni sinei ika mei wor namotan an emon aramas epwe angei aninis chon chiaku. Me mwen ekkewe agency repwe awora aninis ngeni emon chon tingor, mei auchea pwe repwe ekieki won ekkei aruanun poraus/kapaseis:

- Fitemon chon LEP ra keran mochen aninis;
- Fan fitu emon chon LEP a keran tingor ren aninis;
- Ewe popun emon chon LEP a keran tingor ren aninis, ika a auchea ika esap; me
- Ika mei wor naf moni non ewe agency ika ofesen muun.

Ikei Tettenin Ekkoch Angangen Fos Mi Auchea:

- Emon chon fonoom epwe pwisen kapas ngonuk, nupwen ika epwe wor emon chon fonoom mi kan angang non ewe agency;
- Emon chon chiaku epwe pwisen kapas faniton ren om na appointment (ika epwe fituk ren ewe fon);
- Emon chon chiaku epwe siwini ekkoch toropwe mi auchea (mamak), pwe kopwe tongeni weweoch; me
- Ekkewe agency repwe achocho ne awora ngonuk ekkoch website, toropwe me puuk non fosun fonoom.
