    - i. During the month of April and May 2023, OLA and the Hawaii Judiciary will conduct 5 state-wide basic orientation workshops for bilingual individuals who wanted to become interpreters. The purpose is to provide training to increase the number and availability of qualified language interpreters in order to advancing meaningful access for Limited English Proficient (LEP) Persons.
    - ii. OLA, in partnership with, the Hawaii Roadmap Initiative, the University of Hawaii (UH) and the Department of Education (DOE) held the 6th Multilingual Career Development Day on 03/22/2023 at the University of Hawaii. This is an event to raise student awareness of the value of their language skills so that they continue to develop them and look for opportunities to use them in their daily life, in their communities, and in the workforce.
    - iii. Legislative Updates:
      - SB814 Requires the Office of Enterprise Technology Services, in consultation with the Office of Language Access and a working group composed of stakeholders, to develop and publish, and periodically review and update, electronic information technology multilingual accessibility standards to be implemented by all state entities.
        - Pending a hearing before The House Committee on Finance.
      - SB813 Requires the Judiciary to increase the hourly fees, mileage reimbursement rate, and commuter-time compensation rate for court interpreters. Appropriates funds.
        - Pending a hearing before the House Committee on Finance.
      - SCR32/SR26 HCR186/HR191 Requesting OLA to establish an American Sign Language (ASL) working group to increase the number of ASL interpreter in the State.
        - The Senate Committee on Health and Human Services and the House Committee on Health &

Homelessness passed these resolutions with amendments and required DCAB rather than OLA to convene the working group.

- SCR206/SR105 HCR155/HR156 Requesting the Hawaii Tobacco Quitline to make permanently visible on each page of its website information pertaining to the availability of translation services upon request.
  - The Senate Committee on Health and Human Services deferred the senate version, but the House Committee on Labor and Government Operations passed the house version with proposed amendments from OLA to change from translation services to interpretation services.
- SB812/HB439 Establishes and appropriates moneys for an immigrant services and access unit within the Office of Community Services.
  - The bill is dead this session
