KAKALAMEKO, Kale. – Nā hō‘ai‘ē pōpilikia ‘eha kālā pekelala kuleana-lalo (EIDL) I kēia manawa, hiki iā ‘oihana li‘ili‘i a me nā hui waiwai puka ‘ole pono‘ī nui i Hawai‘i, ‘o Honolulu lāua ‘o Kaua‘i nā kalana e hopena e ka ho‘omaka ‘ia o nā ahi ‘āhui ma ka ‘Aukake 8 i ke kalana Maui, ua hō‘ike e ka luna ho‘oponopono i kapu ‘ia ‘o Isabella Casillas Guzman o ka hui ‘o U.S. Small Business Administration.

‘O kēia kuahaua ho‘ololi ‘ia e ‘ae i ka SBA e ho‘onui ‘āwīwī i ka hiki i ka nā hō‘ai‘ē pōpilikia ma‘ō aku nā kalana ‘o Māui lāua ‘o Kalawao i mea e ola a ola hou i ka pōpilikia kālā o nā ‘oihana ma kēlā ‘ao‘ao o ka Moku‘āina,“ ua ‘ōlelo e ka luna ho‘oponopono ‘o Guzman. “He hana o kēia lā e kōkua i ka hā‘awi aku maka ho‘okō o ka Pelekiken Biden e kāko‘o i nā kumu hiki āpau a me ka ho‘okokoke aupuni-o-holo‘oko‘a e pa‘a a me nā kaiāulu kokoke āpua e kūkulu ikaika hou.”

He hoomakaukau no nā hō‘ai‘ē EIDL i ka ho‘ohuli kālā o ka pōpilikia wale nō a me ka pohō waiwai ‘ole. Loa‘a nā ‘oihana li‘ili‘i i ka helu kuwala o ka pākēneka 4 a am me ka pākēneka o 2.375 no nā hui waiwai puka ‘ole pono‘ī nui me nā kau o nā makahiki 30 ā keu, a me nā ‘oihana li‘ili‘i e kapu me ka hiki kālā ‘ole e ho‘ohuli i nā ho‘ololi me ka pōpilikia ‘ole.

E penei ana i nā ho‘ohuli hou o ka lula SBA, he kuwale e ho‘omaka ‘ole ā hiki i nā mahina 12 mai ka lā o ka ho‘oku‘u hō‘ai‘ē pōpilikia mua. He uku o ka hō‘ai‘ē pōpilikia ‘o SBA e ho‘omaka i nā mahina 12 mai ka lā o ka ho‘oku‘u mua.
