- (a) OLA Executive Director Report
  - i. During the month of June 2024, OLA conducted language access training titled "Who should we use an interpreter?" in Maui, Hilo, and Honolulu. The training sessions focused on identifying and selecting the most appropriate interpreters for their clients, ensuring effective communication across language barriers. Attendees learned the differences between competence and qualifications, explored best practices in interpreter selection, and understood ethical considerations. The training will be offered to participants in Kona, Kauai, Honolulu, and online during the month of July 2024.
  - ii. On Friday, June 7, 2024, the OLA Executive Director visited and met with the Waipahu High School student translators to share information about the Hawaii Language Access Law, and pathways in interpreting and translating. This is the second summer that Waipahu High School is running a student translator program to promote the language talents among students who are bilingual or multilingual.
  - iii. OLA has completed a new language access training video titled "Hawaii Language Access Basics Training." This video is specifically designed for state employees and staff of state-funded programs, providing foundational knowledge on language access and its importance in serving our diverse communities.

In this video, viewers will learn about key concepts, legal requirements, and best practices for ensuring effective communication with individuals who have limited English proficiency. Our goal with this training is to expand our educational efforts and raise awareness about language access, ultimately achieving meaningful access for all persons with LEP in our state.
