STFPS TO SELF-CERTIFY YOUR RESTAURANT

If you do not serve kids combo meals inclusive of a beverage, STOP HERE.

> At this time, <u>Hawai'i Revised Statutes § 321-30.3</u> does not apply to your restaurant. In the future, meal bundled with a beverage for a single price, the law will apply to your business and you will be required to self-certify your restaurant at that time.



If you serve kids combo meals inclusive of a beverage, please complete the Self-Certification Form on https://healthybydefault.hawaii.gov. Please be prepared to upload pictures of your menus to verify that they are in compliance with the law.

In accordance with <u>Hawai'i Revised Statutes § 321-30.3</u>, all Hawai'i restaurants that serve a children's meal with a beverage for a single price shall offer a healthy beverage as the default option. All restaurants that serve a children's meal with a beverage for a single price are required to certify that they comply with the law.





If you serve kids combo meals inclusive of a beverage, and the current default beverage offered on your menus and verbally is not:



Water



Plain milk (1% or low-fat and 8oz or less)



100% fruit or vegetable juice (8oz or less)

as stated in Hawai'i Revised Statutes § 321-30.3, please make the appropriate changes to ensure your menus are in compliance with the law.



If you serve kids combo meals inclusive of a beverage, and the current default beverage offered on your menus and verbally is:



Water



Plain milk (1% or low-fat and 8oz or less)



100% fruit or vegetable juice (8oz or less)

as stated in Hawai'i Revised Statutes § 321-30.3, your menus are in compliance with the law.



Once the changes have been made to ensure your menus are in compliance with the law, please return to https://healthybydefault. hawaii.gov and certify that your restaurant complies with the law.

At-A-Glance Compliance Checklist



Verbally

food establishment employees must relay to patrons the healthy default beverage options if a kids meal is ordered.



In-store and online menus

must list ONLY healthy beverage options for kids meals, specifically:

- O Plain Milk must be listed as 1% or nonfat
- O Juice must be listed as 100% juice
- No refills other than water



All menus

breakfast, lunch, and/or dinner - if they include kids meals, must list healthy beverages to be in compliance.



All images of kids meals

must show a healthy default beverage.
