A DAC is currently defined as a public water system’s community with an affordability score of 30 or greater (out of 100), based on the DWSRF Priority Scoring Model and as demonstrated in the 2021 Hawaii Water Rates Dashboard and Hawaii 2015-2019 American Community Survey 5-year Estimates by Census Tracts & Legislative Districts.

Amendment 1 Updates

A DAC is currently defined as a public water system’s community with an affordability score of 30 or greater (out of 100), based on the DWSRF Priority Scoring Model and as demonstrated in the 2021 Hawaii Water Rates Dashboard and Hawaii 2015-2019 American Community Survey 5-year Estimates by Census Tracts & Legislative Districts. **Additionally, the program is also expanding DAC designation to areas that are considered disadvantaged on the Climate and Economic Justice Screening Tool<sup>1</sup> that would otherwise not meet the original DAC criteria of the DWSRF Priority Scoring Model.**
