ADMINISTRATOR'S REPORT April 2013

Subarea Health Planning Councils (SACs) Activities

Kauai

Members met on March 22, 2013 and received an update on the Kauai Community Health Needs Assessment from Dr. Dileep G. Bal, Kauai District Health Officer. In addition, members discussed the Draft Assets Map.

Honolulu

Members met on March 7, 2013. Ms. Jennifer Jung and Mr. Bow Mun Chin, attorneys from the Hawaii Immigrant Justice Center at the Legal Aid Society of Hawaii, provided an overview of the federal and state language access laws and the types of reimbursements for health care services that providers may seek with the assistance of the Hawaii Immigrant Justice Center. They spoke about the law, and who must comply with the law, defined what is national origin discrimination and Limited English Proficiency. They reviewed meaningful access, how to develop a language access plan, vital documents, and "safe harbor" for translations. Finally, they provided an overview on how reimbursement may be sought in various ways such as from the Crime Victim Compensation Commission or being approved as a VAWA or T recipient.
