ADMINISTRATOR'S REPORT April 2012

Subarea Health Planning Councils (SACs) Activities

Kauai Members are scheduled to meet on May 2, 2012.

Honolulu Members met on March 1, 2012 with Mr. Jack Ashby, of the Hawaii Medical Services Association. Mr. Ashby provided an overview of accountable care payment options with a focus on bundled payment and the full accountable care organization model. The goal of accountable care payment is to drive improvements in the quality and efficiency of health care delivery by 1) aligning the incentives of physicians and hospitals, and 2) improving providers' processes and coordination in the delivery of care. He described major forms of accountable care payments, identified key design options, outlined the applicable Medicare programs, and addressed their potential development in Hawaii.
