ADMINISTRATOR'S REPORT December 2011

Subarea Health Planning Councils (SACs) Activities

Kauai

Members met on November 9, 2011 and heard from guest presenter, Dr. J.B. Sampsell, Psychiatrist at the Kauai Community Mental Health Center, Hawaii Department of Health. Dr. Sampsell briefed members on the State of Mental Health Services on Kauai. He provided a historical review of the Community Mental Health Centers (CMHCs); and described the forensic/legal system; the limited resources in the community; nature and extent of psychiatric evaluation; challenges with the policies relating to eligibility (insurance and diagnosis) for CMHC services; and loss of the continuity of care.

Members are scheduled to meet on February 17, 2012, to hear a presentation given by Dr. Dileep G. Bal, District Health Officer, Kauai District Health Office, regarding *Tropic Care Kauai 2012*.

Honolulu

Members met on November 3, 2011. Mr. Keith Lee and Mr. Lloyd Lim briefed members on the certificate-of-need (CON) application review process using a previously approved CON application. In addition to a general overview of the CON process, members who had participated in previous CON hearings gave personal anecdotes of their experiences.

Members of the West Oahu SAC and Windward Oahu SAC held a joint meeting on November 16, 2011, and heard a presentation by Hilton Raethel, Senior Vice President of the Hawaii Medical Service Association, entitled "Quality Payment Systems".
