ADMINISTRATOR'S REPORT November 2011

Subarea Health Planning Councils (SACs) Activities

Kauai

Members met on October 19, 2011 to review Certificate of Need application #11-14 from Ohana Home Health, LLC for establishment of Medicare certified home health agency. Members are scheduled to meet on November 9, 2011, and hear from guest presenter Dr. J.B. Michael Sampsell, Psychiatrist of the Kauai Community Mental Health Center, Hawaii Department of Health. Dr. Sampsell will share his insights on "The State of Mental Health Services on Kauai".

Honolulu

Members met on October 6, 2011 to review and rank the proposed list of activities that was discussed at the last HONSAC meeting in August. After the ranking exercise, the activities for the 2011-2012 year will include building on the Got Nutrients? message, providing more training for the certificate-of-need process, and inviting speakers to present information on the new healthcare law (e.g. accountable care organizations).

West Oahu & Windward Oahu

Members of the West Oahu SAC and Windward Oahu SAC will hold a joint meeting on November 16, 2011, and hear from guest presenter: Mr. Hilton Raethel, Senior Vice President of the Hawaii Medical Service Association. Mr. Raethel's presentation is entitled: Quality Payment Systems.

Tri-Isle

Members met on October 7, 2011 and heard from guest presenter Dr. George Talbot of Kaiser Permanente. Dr. Talbot delivered a powerpoint presentation on *Health Care Reform*. He briefed members on the Patient Protection and Affordable Care Act and the Health Care and Education Reconciliation Act. He also spoke about the American Recovery and Reconciliation Act as it related to the Health Information Technology for Economic and Clinical Health.
