# ADMINISTRATOR'S REPORT September 2013

## **Subarea Health Planning Councils (SACs) Activities**

Kauai

No meeting in August and September. Members are scheduled to meet

in October.

Honolulu

Members met on August 15, 2013. Ms. Madi Silverman provided an overview of Medicaid home and community based services (HCBS) in Hawaii. She reviewed the enabling legislation, the principal aims of HCBS, and described all HCBS services offered such as case management, personal assistance/chore, adult day care, adult day health, respite, expanded ARCH, etc. Self-direction (or the opportunity to have choice and control over HCBS providers) is allowed for some of the services offered. Ms. Silverman spoke about the ongoing efforts to support de-institutionalization (e.g. closure of Waimano Training School and Hospital), past Center for Medicare and Medicaid Services Nursing Facility Transition Grants, and the current Money Follows the Person grants that was used to establish the Hawaii's Going Home Plus Project (Project). The Project is working on more nursing facility relocation strategies, discharge planning for success, and addressing discharge barriers. Finally, Ms. Silverman spoke about HCBS quality framework assurances. Next meeting is September 5, 2013.

West Oahu No meeting in August. Members are scheduled to meet on September 4, 2013 and hear from Ms. Jennifer Ryan who will offer a presentation on "Wellness in Schools."

Windward Oahu
