ADMINISTRATOR'S REPORT August 2014

Subarea Health Planning Councils (SACs) Activities

- Kauai** The Kauai County Subarea Health Planning Council members met on July 14, and were briefed by Mr. Lyle Tabata, Co-Chair, Kauai Community Health Improvement Initiative's *Workgroup on Community Design and Planning*. Members learned about the *Workgroup on Community Design and Planning*, including the vision, goal, and strategic issues. The workgroup joined forces with the existing Get Fit Kauai Built Environment Task Force. The joint effort is focused around three areas: 1) improve roadway standards; 2) improve bike and pedestrian facilities; and 3) improve transit.
- Honolulu** The Honolulu Subarea Health Planning Council met on July 3, 2014. Members continued their discussion on the early detection and diagnosis of the Alzheimer's disease public awareness project. The next meeting is August 7, 2014.
