ADMINISTRATOR'S REPORT December 2013

Subarea Health Planning Councils (SACs) Activities

Kauai The Kauai County Subarea Health Planning Council did not meet in November.

Honolulu Members met on November 7, 2013. Members decided to work on a public awareness campaign for the early detection and diagnosis of Alzheimer's disease.

West Oahu and Windward Oahu

The West Oahu and Windward Oahu Subarea Health Planning Councils did not meet in November.

Tri-Isle The Tri-Isle Subarea Health Planning Council members met on November 8, 2013, and heard from Dr. Lorrin Pang who offered a presentation entitled "Critical Health Issues for Maui County". Dr. Pang provided an overview on the emerging health issues relating to medication usage; oral health; older adults; methamphetamines; obesity; homelessness and poverty; and toxic exposures from pesticides.

Hawaii Members met on November 26, 2013. The members discussed several possible activities for the upcoming year. Members also decided that they would hold quarterly meetings (other than Hilo) at various health care settings if possible to get more familiar with the health care activities and challenges in the different communities throughout the county.
