ADMINISTRATOR'S REPORT March 2017

Subarea Health Planning Councils (SACs) Activities

- Kauai** The Kauai County Subarea Health Planning Council (KCSAC) met on February 9, 2017. Dr. Janet Berreman, the new Kauai District Health Officer, was the guest speaker. She talked about her background and experience, and discussed her thoughts on promoting public health on Kauai. The next meeting will be on May 11, 2017.
- Honolulu** The Honolulu Subarea Health Planning Council (HONSAC) met on February 2, 2017. The members continued their work on the elder abuse project. The next meeting will be March 2, 2017.
- West Oahu** The West Oahu Subarea Health Planning Council (WOSAC) did not have a scheduled meeting in February 2017. The next meeting will be on March 8, 2017.
- Windward Oahu** The Windward Oahu Subarea Health Planning Council (WISAC) did not have a scheduled meeting in February 2017. The next meeting has not been scheduled.

Research and Statistics

The Hawaii Health Data Center (HHDC) Project Team

The HHDC team continues to work closely with the State's Chief Information Security Officer to review and update the claims data security plan.

The project team has completed all planned meetings with insurers to get their input and feedback on the Data Submission Guide. The Data Submission Guide is being updated and will be released shortly.

The interim administrative rules were modified and will be re-submitted to the Department of Health for additional review, and then sent to the Governor for signature.
