### Subarea Health Planning Councils (SACs) Activities

### Research and Statistics

As of 04/30/2017, SHPDA's annual health care utilization survey for Calendar Year 2016 was distributed to a total of 101 health care facilities/providers. The response rate for the survey was at 21%.

### **The Hawaii Health Data Center (HHDC) Project Team**

The HHDC team began its work with Freedman Health. The consultant is providing subject matter expert advice in preparation for data submission. The APCD Best Practices training topics are under review.

Project updates were provided to Senator Rosalyn Baker, Chair of the Senate Committee on Commerce, Consumer Protection and Health, and to Representative Della Au Belatti, Chair of the House Committee on Health.
