ADMINISTRATOR'S REPORT October 2014

Subarea Health Planning Councils (SACs) Activities

Kauai

The Kauai County Subarea Health Planning Council's next meeting will be held on October 16, 2014. Mr. Kamuela Cobb-Adams, Director of the Kauai County Housing Agency will provide an update on the Kauai Community Health Improvement Plan's Workgroup on Housing.

Honolulu

The Honolulu Subarea Health Planning Council met on September 4, 2014. The members continued their discussion on the early detection and diagnosis of the Alzheimer's disease public awareness project. Their next meeting is October 2, 2014.

West Oahu and Windward Oahu

The West Oahu Subarea Health Planning Council met on September 4, 2014, and heard from Mr. Richard Bettini, President and CEO of the Waianae Coast Comprehensive Health Center (WCCHC). Mr. Bettini briefed members on the WCCHC, a non-profit community owned corporation. WCCHC is an economic engine in the community, providing training for the workforce and employment.

Tri-Isle

The Tri-Isle Subarea Health Planning Council members met on September 12, 2014, and were updated on the work of the Maui County Office on Aging (MCOA) by Ms. Deborah Stone-Walls, County Executive on Aging. Members received information on the Aging Disability Resource Center; Care Transition Program; Enhance Fitness Program; Better Choices, Better Health Program; and the Veterans Self-Directed Program. Ms. Stone-Walls also spoke about the possibilities of what the year 2020 will look like for the aging baby boomers population.
