ADMINISTRATOR'S REPORT January 2018

Subarea Health Planning Councils (SACs) Activities

Kauai The Kauai County Subarea Health Planning Council (KCSAC) did not have a scheduled meeting in December 2017. The next meeting will be on February 8, 2018.

Honolulu The Honolulu Subarea Health Planning Council (HONSAC) did not meet in December 2017. The next meeting is on January 4, 2018.

West Oahu and Windward Oahu

The West Oahu Subarea Health Planning Council (WOSAC) and the Windward Oahu Subarea Health Planning Council (WISAC) meeting that was scheduled for December 13, 2017 was postponed to January 10, 2018.

Tri-Isle The Tri-Isle Subarea Health Planning Council (TISAC) met on December 1, 2017. Dani Riggs, clinical director at the Maui Child and Family Services, gave a presentation on "Health Implications of Sexual Abuse." Copies of his PowerPoint presentation were distributed. The next meeting is tentatively scheduled on March 2, 2018.

Hawaii The Hawaii County Subarea Health Planning Council (HCSAC) met on December 5, 2017.
