### Subarea Health Planning Councils (SACs) Activities

**Kauai** The Kauai County Subarea Health Planning Council (KCSAC) meeting that was scheduled for February 8, 2018 was cancelled. The next meeting will be on March 8, 2018.

**Honolulu** The Honolulu Subarea Health Planning Council (HONSAC) met on February 1, 2018. Members met with Ms. Colette Kon, RN, MSN, and her fellow staff to learn about the Geriatric, Rehabilitation, & Extended Care Center of the Veteran's Affairs Pacific Islands Health Care System. The next meeting will be March 1, 2018.

### **West Oahu and Windward Oahu**

The West Oahu Subarea Health Planning Council (WOSAC) and the Windward Oahu Subarea Health Planning Council (WISAC) did not have a meeting in February 2018. The next joint meeting will be on March 7, 2018.

As of 02/28/2018, the response rate for SHPDA's annual health care utilization survey for Calendar Year 2017 was at 15%.

### **The Hawaii Health Data Center (HHDC) Project Team**

The interim administrative rules are awaiting approval from the Governor. After receiving the Governor's approval, they will be filed with the Lieutenant Governor's office.

The project team has been working with representatives from HMSA, Kaiser, CVS, HDS, and VSP in preparation for data submission. Weekly/semi-weekly question-and-answer calls are taking place with CVS, HDS and VSP.

House Bill No. 2361 is no longer active. House Bill No. 694 House Draft 2 replaced House Bill No. 2361, and successfully crossed over to the Senate. Senate Bill No. 2788 successfully crossed over to the House.
