Subarea Health Planning Councils (SACs) Activities

Kauai The Kauai County Subarea Health Planning Council (KCSAC) did not meet in

August 2021. The next meeting will be on September 16, 2021.

Honolulu The Honolulu Subarea Health Planning Council (HONSAC) did not meet in

August 2021. The next meeting will be on October 7, 2021.

West Oahu and Windward Oahu The West Oahu Subarea Health Planning Council (WOSAC) and the Windward Oahu Subarea Health Planning Council (WISAC) did not meet in

August 2021. The next joint meeting will be on September 15, 2021.

Tri-Isle The Tri-Isle Subarea Health Planning Council (TISAC) did not meet in August

Research and Statistics

As of August 31, 2021, the response rate for SHPDA's annual health care utilization survey for calendar year 2020 was at 94.3%. The research statistician is working to review and verify the information submitted by the health care providers, and to enter data for analysis. Health care providers who did not submit their 2020 utilization survey by the May 31 deadline were contacted by emails and/or phone calls regarding their submission.
