Presentation	A presentation on the "Access to Care Project" (ATCP) was given by Lisa Grove, President and CEO of Grove Insight and Lisa Rantz, Executive Director, Hilo Medical Center Foundation.	
	A discussion followed. The Access to Care report, is the first of its kind and takes a comprehensive look at the health care needs of Hawaii residents. Assessments have been conducted in the past, but nothing this comprehensive. The ATCP was funded with American Rescue Plan Act "ARPA" funds through the Centers for Disease Control and Prevention "CDC".
