## **Subarea Health Planning Councils (SACs) Activities**

#### Hawaii

The Hawaii County Subarea Health Planning Council met on February 21, 2023. A presentation on "HOPE Services Inc." was given by Brandee Menino, Executive Director and Dr. Kalani Spain, Clinical Director. The presentation was followed by an update and next steps on the "Accessing Healthcare Services on Hawaii Island". The next meeting is scheduled for March 21, 2023.

#### Honolulu

The Honolulu Subarea Health Planning Council (HONSAC) met on February 9, 2023. The HONSAC backup lead representative to the Plan Development Committee was elected followed by Standing Committee updates. The Bylaws were discussed, and a Task Force created to review/update the Bylaws. The next meeting is scheduled for March 9, 2023.

#### Kauai

The Kauai County Subarea Health Planning Council (KCSAC) met on February 21, 2023.
