ADMINISTRATOR'S REPORT
April 2023

Subarea Health Planning Councils (SACs) Activities

- Hawaii** The Hawaii County Subarea Health Planning Council (HCSAC) met on March 21, 2023. The Accessing Healthcare Services on Hawaii Island project update and discussion was deferred. A task force will be convened to review the HCSAC Bylaws and Priorities. The next meeting is scheduled for April 18, 2023.
- Honolulu** The Honolulu Subarea Health Planning Council (HONSAC) met on March 9, 2023. The Bylaws Taskforce suggested revisions to the current bylaws followed by a brief discussion. The Priorities were revisited by the Plan Development Subcommittee and will be further discussed after receiving additional data/information from various organizations. A survey to HONSAC members will be disseminated to assess gaps in current membership and assist with creating a targeted recruitment approach. The next meeting is scheduled for April 13, 2023.
- Kauai** The Kauai Subarea Health Planning Council met on March 14, 2023. The discussion on member recruitment continued and an update on the Community Healthcare Needs Assessment Project was provided; a project report will be drafted. The next meeting is scheduled for May 9, 2023.
- Tri-Isle** The Tri-Isle Subarea Health Planning Council did not meet in March. The next meeting is scheduled for June 23, 2023.
- West Oahu** The West Oahu Subarea Health Planning Council (WOSAC) met on March 15, 2023. A presentation "Healthcare Workforce Needs – West Oahu" was given by Lord Ryan Lizardo, Work-Based Learning, Chamber of Commerce Hawaii. The next meeting is scheduled for May 17, 2023.
- Windward Oahu** The Windward Oahu Subarea Health Planning Council did not meet in March 2023. The next meeting has not been scheduled.
