Subarea Health Planning Councils (SACs) Activities

- Hawaii** The Hawaii County Subarea Health Planning Council did not meet in May. The next meeting is scheduled for June 20, 2023.
- Honolulu** The Honolulu Subarea Health Planning Council met on May 11, 2023. Janna Hoshide, Senior Director of Workforce Development, Healthcare Association of Hawaii presented on "The Healthcare Workforce Initiative" and Jodi Hashimoto, Partner, SH Consulting, LLC, presented on the "Community Health Needs Assessment". Updates were provided by the Plan Development and Membership Standing Committees; and the SHPDA Administrator provided a briefing on health systems reform. The next meeting is scheduled for June 8, 2023.
- Kauai** The Kauai County Subarea Health Planning Council's meeting scheduled for May 9, 2023 was cancelled. The next meeting is scheduled for June 13, 2023.
- Tri-Isle** The Tri-Isle Subarea Health Planning Council did not meet in May. The next meeting is scheduled for June 23, 2023.
- West Oahu** The West Oahu Subarea Health Planning Council met on May 17, 2023. The SHPDA Administrator provided a briefing on health systems reform. Followed by a review and discussion of the WOSAC priorities and member recruitment. The next meeting is scheduled for July 19, 2023.
