#### ADMINISTRATOR'S REPORT November 2023

### **Subarea Health Planning Councils (SACs)**

#### Hawaii

The Hawaii County Subarea Health Planning Council met on October 17, 2023. No significant updates to the Accessing Healthcare Services on Hawaii Island project; students continue to work on the development of scripts and acting out scenarios. An update on SHPDA's 2023-2024 priorities was provided including the intent to apply for the States Advancing All-Payer Health Equity Approaches and Development (AHEAD) Model Grant, Centers for Medicare and Medicaid Services. The next meeting is scheduled for November 21, 2023.

#### Honolulu

The Honolulu Subarea Health Planning Council met on October 12, 2023. The standing committees provided updates. An update on SHPDA's 2023-2024 priorities was provided including the intent to apply for the States Advancing All-Payer Health Equity Approaches and Development (AHEAD) Model Grant, Centers for Medicare and Medicaid Services. The next meeting is scheduled for November 9, 2023.

#### Kauai

The Kauai Subarea Health Planning Council did not meet in October. The next meeting is scheduled for December 12, 2023.

#### Tri-Isle

An update on SHPDA's 2023-2024 priorities and legislative requests was provided including the intent to apply for the States Advancing All-Payer Health Equity Approaches and Development (AHEAD) Model Grant, Centers for Medicare and Medicaid Services. The necessity of data to effectively and accurately measure how the state is doing in healthcare was discussed. The

next meeting has not been scheduled.

**Keiki** The Keiki Advisory Council did not meet in October. The inaugural meeting

has not been scheduled.

**Kupuna** The Kupuna Advisory Council did not meet in October. The inaugural

meeting is scheduled for November 2, 2023.

Universal The Universal Access Advisory Council did not meet in October. The

inaugural meeting is scheduled for November 16, 2023.

# **Health System Reform**

SHPDA has been moving forward at near warp speed on several urgent priorities related to health system reform as follows:

- 1. We have added 60 more high-profile volunteer health sector advisors for our 4 new advisory councils on Keiki Care, Kupuna Care, Health Data, and Universal Access. Maternal health will be added later. The councils are already meeting to suggest priorities for health care innovation in their priority areas, noting that prevention needs to be a higher priority than sick care for improving population health. The results of council deliberations will be referred to the SHPDA Plan and Development Committee (PDC) and then on to the Statewide Health Coordinating Council (SHCC). Upon their review, recommendations will go to the Governor and the Legislature.
- 2. We are proposing that the Legislature sponsor with us and the Administration a new Task Force on the Future of Health Care and specifically on a strategy for achieving "universal access to high-quality, equitable, and *affordable* health care for all.
- 3. SHPDA and MedQUEST are co-chairing the Hawaii proposal development for successful application for the new CMS "AHEAD" grant, which could bring millions in health system innovation planning funding and hundreds of millions in implementation funding over 10 years. The Task Force, and the new Advisory Councils will be helpful and serve as indicators of the seriousness of getting this highly competitive grant, which only 8 states will receive.
- 4. We will be working with DOH, DHS, DCCA and the Insurance commissioner and others on these efforts.

The SHPDA Administrator is reaching out with formal presentations to statewide acute hospital CEOs and CMOs, to the Hawaii Association of Health Plans, to the Critical Access Hospitals, to HI-AARP, the Hawaii Primary Care Association and the FQHCs, to the Hawaii Medical Association, the HI-IPA and PMAG independent physician associations, and to Papa Ola Lokahi, Hui Pohala, Kokua Mau, and others. While workforce shortages and rural health gaps and rising costs are top priorities, we are also summarizing other issues that these and other stakeholders believe must be addressed if the "Hawaii the Health State 2025" vision is to be achieved.
