State Health Planning and Development Agency (SHPDA) Updates	W. Nihoa, Comprehensive Health Planning Coordinator, SHPDA, reported on behalf of J. Lewin, Administrator, SHPDA.	
	2024 Legislative updates. Two bills highlighted: Senate Bill (SB) 2285 and SB 3129 (companion House Bill 2728). First hearings completed for both. Both bills have gone through first hearing.	
	SB 2285-Amends the functions and duties of the State Health Planning and Development Agency. Clarifies the definition of "health care". Establishes a task force known as the Hui Ho'omana. Establishes positions. Appropriates funds.	
	SB 3129 Establishes the Hui Ho'omana Task Force within the State Health Planning and Development Agency to develop a comprehensive plan to provide universal access to equitable and affordable high-quality health care for state residents, including defining action plan items, setting timeline and deadline for each action item, and identifying resources required and funding options. Requires reports to the Legislature.	
	J. Lewin, Administrator, SHPDA, provided an update on the AHEAD (Advancing All-Payer Health Equity Approaches and Development Model) Grant. SHPDA and the Department of Human Services MedQUEST continue to collaborate on the grant application due on March 18, 2024. J. Lewin noted the first 30-months of the project will provide opportunity for input from the Keiki Advisory Council.
