It was then moved/seconded to recommend disapproval of the application. The motion to recommend disapproval included the attached review of the application's relationship to Certificate of Need criteria. (see attached)

The Certificate of Need Review Panel met on March 21, 2024 to review the above-noted application.

The Panel recommends disapproval of this application by a vote of 5 to 1, and offers the following comments:

- The applicant did not provide sufficient data to demonstrate the need for the proposed project. Some of the data provided by the applicant was inaccurate.
- The applicant did not meet the relationship to the existing healthcare system criteria. The applicant did not sufficiently demonstrate its proposed relationship to other healthcare providers in the state.
