Establishes positions. Appropriates funds. Measure passed through six (6) committees, currently in conference.	
	The All-Payer Health Equity Approaches and Development Model (AHEAD) Grant. Application to the Centers for Medicare and Medicaid was submitted on time. Hawaii applied to the AHEAD Cohort 2 which will allow for 2.5 years of planning during the Pre-Implementation phase.	
	SHPDA will be looking to the KCSAC to provide advice on priorities and issues at the county level.
