|  | 2024 Legislative Session: Senate Bill 2285 to amend the functions and duties of the SHPDA. Clarifies the definition of "health care" and establishes a task force known as the Hui Ho'omana. Establishes positions and appropriates funds. Bill was tabled in conference committee; referred to the 2025 Legislative Session.   |        |
|  | All-Payer Health Equity Approaches and Development Model (AHEAD) Grant. Grant application is under review by the Centers for Medicare and Medicaid (CMS). The Hawaii AHEAD Team (SHPDA and Department of Human Services-MedQUEST) applied for Cohort 2. Questions were received from CMS; The Hawaii AHEAD team successfully submitted a response. The award notification is anticipated in mid-June 2024; grant starts on July 1, 2024. If Hawaii AHEAD does not receive an award this round, another round of applications for Cohort 3 is due in September 2024. |        |
|  | The importance of data and data sharing in SHPDA's initiatives was stressed.  |        |

## **Data Needs for SHPDA Health Data Advisory Council**

- 1. Estimation of uninsured and Underinsured:
  - a. Unpaid claims?
  - b. # of unique patients receiving services annually compared to population of island
  - c. Federal DSH payments (DHHS data)
- 2. Primary care services received as a % of all care delivered (using defined CPT or E&M codes)?
  - a. Medicaid
  - b. Commercial insurance (HMSA, KP, other)
  - c. Medicare and Medicare Advantage
- 3. Mainland care provided to Hawai'i residents.
  - a. California
  - b. Nevada and Las Vegas and western states
- 4. Neighbor Island patients receiving specialty or hospital care on O'ahu (by diagnosis, by facility)
- 5. Avoidable ED visits and Inpatient admissions by claims codes
- 6. Inpatient Readmissions by hospital and diagnosis category
- 7. Estimation of Medical Debt accumulated by virtue of claims unpaid, or other means.
- 8. Means to measure gaps in access to care.
- 9. Gaps in care for Hawaiians and Pacific Islanders
- 10. % by population ED Use and Inpatient admissions (by diagnosis type?) in underserved and rural areas and/or low-income zip codes
- 11. Means to measure cost-effectiveness of services provided by diagnosis.
- 12. Health status monitoring for heart disease (ASCVD, heart failure, Atrial fibrillation), cancer (by type), COPD, stroke, trauma care, maternal health, etc.
- 13. Total HI costs of care: Annual Medicaid, Medicare/MA, commercial, and grand total spend.
- 14. Collected the de-identified claims of the 250,000 commercial insured (90% HMSA and KP) not included in the SHPDA APCD claims mandate.
- 15. Per capita Medicare/MA spend across HPSA zip codes compared to non-HPSA zips and national averages. (this could be a way to justify GPCI increases and Medicare benchmark adjustment).
