| | In the upcoming legislative session, we plan to address the issue of prior authorization and support a bill that would enable Hawaii to align with other states in lowering pharmaceutical costs. To benefit our patients, we may also need to pursue legislation for the AHEAD model, which may require us to explore various strategies for implementation. Additionally, we are investigating ways to utilize the All-Payers Claims Database to assess Hawaii's performance in areas such as cancer care, heart disease, and both adult and child health, including a breakdown of data by island. | |

HONSAC Priorities

K.F. Davis provided a summary of the ongoing Phase One prioritization process. HONSAC's primary priorities include Workforce Shortage, Mental Health, Kupuna/Long Term Care, Access, and Preventative Care. The document titled "HONSAC Priorities" was shared on screen. At the request of the committee, T. Visperas will send out a Doodle poll to HONSAC members to schedule an in-person meeting to discuss, condense, and refine these priorities beyond the five main categories.

Standing Committee/Other Committee Reports and Updates

K.F. Davis presented the current vacancies and requested nominations. C. Takeno nominated T. Abe Carapelho for the position of Chair, which was accepted by T. Abe Carapelho. K.F. Davis self-nominated for Vice-Chair and for a liaison position on the State Health Coordinating Council (SHCC).

A motion was made to conduct a vote, which was approved unanimously. The results of the vote are as follows: T. Abe Carapelho as Chair, K.F. Davis as Vice-Chair, and K.F. Davis as the HONSAC liaison to the SHCC.

Membership Committee. C. Takeno, Chair deferred till next meeting to present a grid resulting from the member survey administered last year. The information on the grid will help to inform a more targeted recruitment strategy. All agreed that we should continue to recruit and to keep this item on the agenda.

Plan Development Committee (PDC). T. Abe Carapelho reported that the committee is looking at a completion of a State Plan in the fall of 2025, or spring 2026. Target is to have all Subarea Health Committees finish and submit their priorities by mid-year 2025.
