	Other areas AHEAD will look to address is how to figure out medical debt; address problem of prior authorization related to insurance costs; address health inequities and measure performance outcomes for underserved populations; expedite licensing process for healthcare professionals to address workforce shortages; explore innovative care delivery models; utilize community health workers and technology to enhanced home and community-based services; advocate for equitable federal funding and reimbursement rates for Medicare and Medicaid in Hawaii.
