Health System Reform

The health system reform update is largely unchanged from last month. We are onboarding the AHEAD grant and looking to set up new federal accounts to receive AHEAD funds and begin the process of developing the RFPs that will be needed to build the planning process for hospital global budget development and design; expansion of primary care with guarantees of behavioral health and social supports benefits based on annual assessments of all citizens; development of the state equity or health disparities plan; and preparation to begin measuring and monitoring total costs of care to assure ongoing affordability. SHPDA is also evaluating legislation to streamline and ultimately automate prior authorization for insured persons and providers of care.
