- II. Staff reviewed the certificate of need criteria for participants.
- III. Certificate of Need Review:

Application #24-08 for standard review from Pacific Pearl Medical, LLC for the establishment of Positron Emission Tomography/Computed Tomography (PET/CT) scanner services at 250 Kinoole Street, Hilo, HI, at a capital cost of \$2,175,000.

Bruce Guier presented an oral summary of the application. Public testimony was provided by Lillian Matsumoto, Dan Jordan, and Dr. Bridget Bongaard. The Panel members asked questions of the applicant regarding the Certificate of Need criteria. Questions included but were not limited to: the availability of isotopes for the project, the methodology for projecting yearly utilization, and the availability of staffing resources for the proposal.

The motion to recommend approval included the attached review of the application's relationship to Certificate of Need criteria, attached to these minutes as Attachment A. Discussion on the motion included but was not limited to the importance of early diagnosis and the projected utilization for the proposed project.

The Certificate of Need Review Panel met on October 30, 2024 to review the above-noted application. The Panel recommends approval of this application by a vote of 7 to 0.

The Panel offers the following comments regarding the application's relationship to the Certificate criteria:

1. Relation to the State Health Services and Facilities Plan

Met. The proposal will increase access to PET/CT services on Hawaii island.

2. Need and Accessibility

Met. There is a need for the proposal. The proposal will reduce wait times, reduce cost and travel time for PET/CT procedures.

3. Quality of Service/Care

Met. The proposal will lead to earlier diagnoses and improve patient survival rates.

4. Cost and Finances

Met. The proposal will decrease travel time and cost for patients.

5. Relationship to the Existing Health Care System

Met. The service area is currently underserved for the services proposed by the applicant.

6. Availability of Resources

Met. The applicant will provide the necessary human resources for the proposal, including students from the mainland to supplement the supply of area health care workers.
