Health System Reform

SHPDA and Med-QUEST are continuing with the onboarding process of the AHEAD grant. We are creating a subrecipient federal fund mechanism to have AHEAD funds pass through DHS/MQD to DOH/SHPDA. It will require B&F and both departmental directors to sign off on the related MOU and E2 form submissions. We are also redesigning the categories of AHEAD budget narrative amendments to be considered as we learn more about how to plan better for the Pre-Implementation period through Jan1, 2027 and prepare for operational full implementation thereafter through 2035.

SHPDA is also charged with creating a legislative strategy to require health insurer data submission around the status, causes, and issues surrounding prior authorization (PA) practices in Hawai`i. The proposed legislation would also create a short-term (1-2 year) task force or commission representing insurers, physicians, hospitals, other providers, and consumers to develop and adopt means to expedite and automate PA determinations by applying best scientific and clinical standards, guidelines, or appropriate use criteria to most common causes of PA requirement statewide as determined by federal DHHS agencies, and/or academic and professional society peer-reviewed recommendations. If this can be accomplished for all insurers in Hawai`i, the PA process can then be automated easily and PA determinations can be expedited to the benefit of all participants in health care, including the insurers, who currently spend large sums of money contracting out PA decision-making to for-profit mainland corporations.

SHPDA is also determining on behalf of the Governor and Legislature more precise data about the numbers and causes of uninsured persons here (see HHDC section for details).

Research and Statistics

The research statistician is working on the SHPDA's annual healthcare utilization survey document for calendar year 2024. The survey document will be distributed to healthcare providers/facilities in January 2025. The healthcare providers/facilities will be asked to complete the survey for calendar year 2024 by May 31, 2025.

The Hawaii Health Data Center (HHDC) Project Team

The HHDC met in November and reviewed its progress on identifying the numbers of uninsured persons across the state using the latest Census Survey data, and data collected by Laulima (HAH) after evaluating other sources. The numbers indicate that there are about 3-4 % uninsured persons statewide, with very few keiki (around 2%), but with a surprising high rate of uninsured in Hilo, Hawai'i Island of more than twice the statewide expected numbers. We are researching why that is, and if the numbers are accurate. It may be that there are a large number of Pahoa/Puna families that have incomes higher than Medicaid eligibility who are not applying for coverage. A more complete report will be issued in January and will be shared with the Legislature and state agencies.
