Roll Call	Member roll call followed by staff introductions.	
Meeting Minutes	The minutes of the March 14, 2025, meeting was reviewed and unanimously approved.  Call for public testimony – none.	
Administrator's Report	The Administrator's Reports was distributed and reviewed. State Health Planning and	J. Lewin, SHPDA Administrator, provided the following updates:	
Development Agency (SHPDA) Updates	Hospital 250:	
	<ul> <li>Noted that this bill, now law, requires all insurers to report to SHPDA on every denied claim, including the results of any challenges.</li> </ul>	
	Working Group:	
	Announced a new working group launching in <b>September</b> to hold insurers accountable for reducing the burdens of prior authorization.	
	Future Legislation (2026):	
	<ul> <li>Proposed a new, low-cost insurance program for the uninsured, with a focus on prevention and primary care.</li> <li>Expressed concern about the potential increase in the number of uninsured residents due to the "Big Beautiful Bill," especially for those on Affordable Care Act exchanges.</li> </ul>	

## **Kupuna Loha Program:**

- Unveiled a proposal for a volunteer-based program to support high-risk kupuna (elders) who live alone. The program would:
  - Create a registry of vetted and trained volunteers.
  - o Connect volunteers with patients in their local community.
  - Utilize technology (iPads) to link volunteers with nurses, social workers, and doctors.

### **Health Equity Grant (AHEAD):**

- The grant is moving forward but may be postponed for a year, which could be beneficial for hospitals to prepare.
- The name was changed from "equity" to "efficiency" to make it a more bipartisan effort.
- The project steering committee is comprised of 15 members, representing various constituencies.
- All public meetings and information are available on the SHPDA's website.

#### **New Staff:**

• Introduced new SHPDA's staff members, including a new secretary, Paula, and Barbara Yamashita, a former DOH and DHS executive.

#### **Rural Health Fund:**

- Discussed a \$50 billion addition to the "Big Beautiful Bill" for rural health, dispersed in two \$25 billion tranches.
- \$25 billion to be disbursed equally to all 50 states over five years (2026-2030), with Hawaii expected to receive approximately \$100 million per year.
- An additional \$25 billion will be dispersed from 2026-2030, with amounts determined by CMS based on criteria and proposals submitted by the states.
- J. Lewin stated that Hawaii would aim to get another \$200 million from this Federal funds.
