Call to Order	A quorum was established. The meeting was called to order at 11:01 p.m. by M. Ah Ho-Mauga, Chairperson, Kupuna Advisory Council (KAC) presiding.

Special Presentation by Alex Tellez, Sterling Enterprises, HI	A.Tellez, has 17 years of experience in artificial intelligence, shared insights from his work in healthcare, focusing on bridging the gap between social determinants of health and the resources available to support individuals. Previously involved in the creation of Tinder's matching algorithm, his work now centers around matching people with essential health services. He noted that many individuals, especially on the island, face multiple barriers to healthcare, such as transportation and social isolation. This led him to develop a solution that connects people to over 580 local nonprofit organizations catering to various needs like housing, transportation, and meal delivery.	
	The core of the solution presented was a simple digital questionnaire designed to assess an individual's social determinants of health. This tool, which can be used by anyone—not just healthcare professionals—links the responses to available services, generating personalized care plans. Using AI, the system processes the responses and matches individuals with the appropriate services. Once a match is identified, referrals are sent automatically to the respective organizations, ensuring that each person gets the help they need in real-time.	
	The system is designed to handle multiple social determinants of health simultaneously, addressing co-existing challenges such as transportation, isolation, and understanding medical information. A. Tellez highlighted the program's ability to continue reaching out to organizations if initial referrals are unavailable, ensuring that gaps in care are eventually filled. HMSA (Hawaii Medical Service Association) has supported this initiative, recognizing its potential to reduce healthcare costs by

M. Ah Ho-Mauga emphasized the Kupuna Advisory Council's key priorities: food, long-term care, and financing. Our goal is to develop a white paper on these issues. We are in the process of forming a Permitted Interaction Group (PIG) to evaluate both the resources within our group and those available in the broader community. Under the State of Hawaii Sunshine Laws, the PIG can consist of two or more members, but fewer than a quorum. This group can investigate matters related to the Council's business, though no decisions can be made within the PIG itself. The findings and recommendations must be presented to the board in a formal, publicly announced council meeting. Any deliberation and decision-making on the matter can only occur at a properly noticed meeting, which must take place at least six business days after the presentation of the findings and recommendations.

Public testimony – none.

SHPDA Updates

- J. Lewin, Administrator, highlighted key strategies for addressing long-term care financing in Hawaii, emphasizing the creation of a dedicated working group ("PIG group") to explore funding options and program structures. He clarified that while this group could operate outside the advisory council, its findings would need to be reported back to the council for further action. He also discussed opportunities for engagement with local and state initiatives, including legislative support and community-based pilot projects focused on improving long-term care services for Kupuna.
- J. Lewin proposed a pilot project aimed at enhancing home and community-based services to help Kupuna age at home more effectively. He referenced successful models from states like Minnesota and Washington, where resources were shifted from institutional care to home-based services, improving both care quality and cost-efficiency. He suggested that a similar model could be implemented in Hawaii with thoughtful planning and community involvement.

SHPDA continues to monitor the financial challenges facing long-term care, particularly with potential federal funding cuts. He encouraged leveraging state and community resources, citing examples like Palolo Valley, where local initiatives have successfully supported aging populations. He concluded by urging continued creativity and collaboration to build a sustainable long-term care system that uses resources efficiently and meets the needs of Hawaii's aging population.
