

How to cite Hawaii Administrative Rules chapters 11-260.1 to 11-279.1

- Each part of 40 Code of Federal Regulations (CFR) parts 260 to 279 and part 124 (subparts A and B) is incorporated in a different chapter of the Hawaii Administrative Rules (HAR). The proper citation for the Hawaii Administrative Rules analog of a CFR section is constructed by using the federal rule citation followed by “, as incorporated and amended in [HAR chapter number or section number].” The section number in each chapter that incorporates the federal rules in section 1.

- Here are examples of three correct ways to construct a citation for a specific section of the CFR, as it has been incorporated and amended in the State rules. Notice that the CFR part number and the HAR chapter number always match up as shown in the table above.

CFR section	HAR analog
40 CFR §262.16	40 CFR section 262.16, as incorporated and amended in section 11-262.1-1, Hawaii Administrative Rules
40 CFR §260.43	40 CFR §260.43, as incorporated and amended in §11-260.1-1, HAR
40 CFR §273.13	40 CFR §273.13, as incorporated and amended in chapter 11-273.1, HAR

- Some sections of the HAR do not have a corresponding federal citation. These are cited using their HAR section number. For example, “§11-279.1-14, HAR” and “Section 11-262.1-16, Hawaii Administrative Rules.”
