Medications for Opiate Use Disorder (MOUD)

Methadone & Suboxone

Medical and clinical therapy is provided on an outpatient basis for those who have a documented medical history and Opiate Use Disorder (OUD) to heroin, Fentanyl, and/or other opiates, including but not limited to prescription medication.

Outpatient Counseling

Outpatient Counseling is provided for individuals with a history of Opiate Use Disorder (OUD) in addition to other Substance Use Disorders (SUD). Referrals will be made for placement in higher levels of care as appropriate.

Complete BIO-Psycho-Social screening assessment, drug testing, and DSM5 Diagnosis.

Place screening/initial assessment information within the framework of the American Society of Addiction Medicine (ASAM) for Level of Care Placement.

Medical Screening

Clinical case summary and consult with APRN / MD for intake and medication recommendation.






