## Subject: What Data Will Be Migrated from WITS to INSPIRE PLUS?

To Our Provider Partners, Supervisors and Staff.

As we prepare for the transition to the new INSPIRE Plus system, we want to ensure all impacted users understand what data will be migrated from WITS. Below is a breakdown of what will be carried over to support a seamless go-live for provider agencies with treatment and/or prevention contracts.

# **Treatment Data Migration**

#### **Clients:**

- All clients with an active case (Episode of Care in WITS) will be migrated.
- Clients with inactive cases will also be migrated if they meet any of the following criteria:
  - Completed Intake on or after January 1, 2023;
  - Admitted or started a Program Enrollment between 2015–2023; and
  - Completed Intake before January 1, 2015, and closed the case after October 1, 2022.

### **Migrated Case Information Includes:**

- Intakes.
- Screenings (CAGE-AID, BH/BI, DAST-10) and Assessments (ADAD Assessment, DENS-ASI, ASAM).
- Admission, Discharge, and 6-Month Follow-Up details (including Diagnoses & Substance Use).
- Program Enrollments.
- Progress Notes.
- Treatment Plans (Needs, Goals, Objectives, Interventions, Tx Team) Client Medication Records.
- Client Payor Groups.
- Consents & Referrals.

# **Prevention Data Migration**

### **Participants:**

• All participants with an Intake completed on or after January 1<sup>st</sup>, 2015 will be migrated.

# **Migrated Prevention Plan Information Includes:**

- Planned Strategies and Implementations;
- Outcome Indicators, Goals, Baseline Measures, Objectives, Contributing Factors;
- Groups, Group Members, Group Sessions & Attendees; and
- Test Scores.

### **Billing Data Migration**

- All batches created on or after January 1, 2015 will be migrated and referred to as invoices in Inspire Plus.
- Any batches submitted but not adjudicated in WITS prior to October 17, 2025 will be processed by ADAD in Inspire Plus.

We'll continue to share applicable updates as we move closer to Phase 1 Go-Live.
