Commander Navy Region Hawaii letter 5090 Ser N45/044, dated January 23, 2014 provided notification of a confirmed release of JP-8 from Tank 5 at the Red Hill Bulk Fuel Storage Facility. In accordance with the Hawaii Administrative Rules 11-280.1-65.2, the Navy is submitting a quarterly release response report with CD (Enclosures 1 and 2) to notify the DOH of actions taken between September and December 2021 in response to the January 2014 release at the Red Hill underground storage tank site.

Additional supplemental monitoring is ongoing at the Red Hill Facility in response to the May 6, 2021 pipeline breach that occurred in the tunnel and the November 20, 2021 release from a fire suppression drain line. These actions will continue to be monitored and reported separately through the supplemental monitoring program.
