PLEASE POST THIS INFORMATION FOR CASHIERS WIC Check Changes

Starting Thursday, October 6, stores may start seeing some WIC checks with a difference. Hawaii WIC will pilot a new computer system beginning in October and the look of WIC checks will change and food descriptions will be shorter. Stores will need to refer to the **Approved Food List** for details.

The new checks will *slowly* replace the current checks. By July 2017, all the checks will be the new version with shorter descriptions. Checks will be a mix of the current and new until the new are completely distributed across the state.

NEWCASH VALUE VOUCHERS (CVVs) will now be available for 9 – 11 month old infants for FRESH fruits and vegetables only. Frozen versions are NOT allowed for these checks.
