**WIC Check Changes and WIC Identification Folder Changes**

Stores in your area will start seeing WIC checks with a different look. The look of WIC checks will change and food descriptions will be shorter. Stores will need to refer to the **Approved Food List** for details.

By July 2017 all of the checks in circulation will be the new version that have the shorter descriptions. Here are samples of the new versions of the WIC food checks. As the new checks are introduced, you will see a mix of the current WIC checks and the NEW WIC CHECKS (below) as we begin to phase out the current WIC checks.
