

WHOLE WHEAT SINALOA TORTILLAS NO LONGER WIC ELIGIBLE

Sinaloa Brand Whole Wheat Tortillas are no longer WIC eligible. As a result, they have been removed from the most current Hawaii WIC Minimum Stocking Requirements.

- 16 ounces (1 pound)
- Whole wheat

- Big Island Mexican, Don Pancho, La Burrita, Mission, Guerrero, Sinaloa brands only

Can Buy only if listed on the check

- 24 ounces (1 ½ pound) 11 ounces or larger to add up to 24 ounces

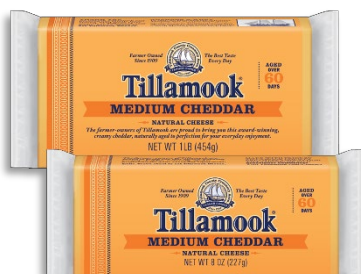
Cannot Buy

- Fried, flavored or seasoned

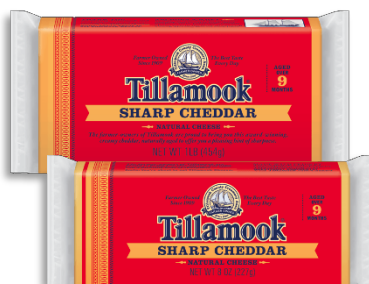


TILLAMOOK CHEESE VARIETIES NOT WIC ELIGIBLE

- Cheddar, Colby, Monterey Jack, Mozzarella, Swiss, any combination of these types
- Regular, reduced or fat-free
- Made in U.S.A. only

Cannot Buy

- Organic
- Sliced, cube, string or deli
- Cheese with peppers, herbs or flavors

- Organic
- Products with added sugars, fats, oils or meat

GERBER INFANT FOODS 2-PACKS

Gerber Infant Foods are sold in **"2 PACKS of 4 OZ"**

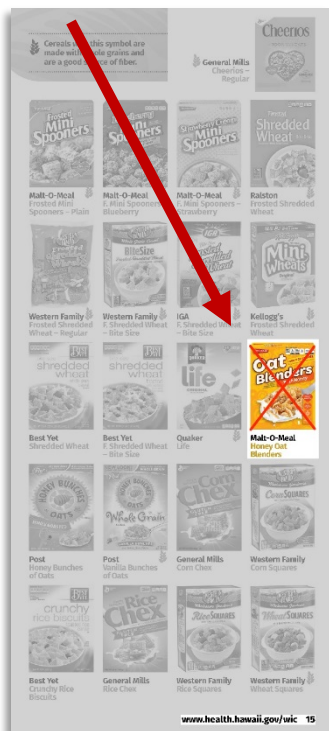


Each 2-pack is equal to **2 CONTAINERS** OF BABY FOOD

EXAMPLE: A WIC check issued for "20 [4 oz] containers Baby Food Fruit and Vegetables" will authorize the WIC participant to purchase **TEN (10)** 2-packs of 4 OZ Gerber infant foods.

MALT-O-MEAL OAT BLENDERS NOT WIC ELIGIBLE

Malt O Meal Oat Blenders with Honey are no longer WIC eligible effective 9/1/17 (pg. 15, Hawaii WIC Approved Food List).
